You can log-in to TRB online **up until 31 December 2024**, to complete your registration payment, renewal or reapplication. Your registration will be processed when we reopen on 2 January 2025.

Please allow a few days for reconciliation of payments and up to four weeks for processing of renewals or reapplications. You will receive an email as soon as your registration is finalised.
